- The EEOC has found that national data indicates criminal record exclusions have a disparate impact based on race and national origin.
 - The EEOC noted that arrest and incarceration rates are particularly high for African American and Hispanic men.
- In addition, recent studies have also found that a significant number of state and federal criminal record databases include incomplete criminal records.
- The Guidance sets forth steps that will allow employers to consistently meet the “job related and consistently with business necessity” test when using criminal history background checks when making employment decisions.
- Compliance with other federal laws/regulations in conflict with Title VII is a defense to a discrimination charge; depending on the circumstances, a state or municipal law may provide a defense or may be preempted.
- The EEOC discusses best practices which employers may take in order to adhere to Title VII of the Civil Rights Act of 1964, and on what grounds the employer must prove that an individual is unfit for employment based on the finding of a criminal record.
